Camden BPW BARN SALE—2016 General Show Rules

1. Applicants agree to donate their time and talent to perform at Barn Sale_{sm}.
2. Barn Sale Entertainment Committee must approve, prior to Sale day, all performance and/or talent categories from the list supplied on the application. Performers must adhere to approvals and may not change performance and/or talent categories without approval of the Entertainment Committee.
3. No donations may be solicited.
4. No crafts or food may be sold.
5. Camden Barn Sale Committee will provide a stage and basic sound equipment. It is the responsibility of each performer to provide any additional equipment needed. Camden Barn Sale Committee is not responsible for damaged or lost equipment.
6. It is suggested that performers, especially those performing in the morning, arrive early on Sale day as the traffic around the Sale area is very congested.
7. No vehicles will be allowed in the Sale area between the Sale times of 8:30 a.m. and 4:30 p.m.
8. Because vehicles are not allowed in the Sale area after 8:30 a.m., performers should make arrangements with the Entertainment Committee for assistance in transporting any additional equipment that will be needed for performances.
9. Please be aware that some streets around the Sale area are designated one-way on Sale Day. **All** workers and volunteers **must** observe one-way street designations and **are not** allowed to travel on **any** one-way street against the traffic.
10. Performers will be allowed to park in the volunteer area if they have a proper parking pass. The Barn Sale chair is responsible for issuing parking passes to the Entertainment Committee chair for distribution to performers. **No volunteers are allowed to park in the volunteer parking area without the proper parking pass.**
11. Overnight parking of vehicles or campers inside the Sale area is prohibited.
12. A professional standard of conduct and dress is expected at all times.
13. Failure to abide by any of the rules governing this show will prevent the performer from being accepted to next year's Sale.
